## **Extract from the Regulations for the Participants in the Trade Fairs to be organised by or on behalf of ICEM.**

### **Relevance of the Regulations for the Participants:**

The general conditions in the Regulations for the Participants that ICEM filed at the Chamber of Commerce of Rotterdam in June 2006 apply to this agreement and to possible other agreements with ICEM, regardless of any diverging stipulation in any document coming from participants or thirds. The full text of the Regulations for the Participants can be obtained at request.

### **Registration for stand space:**

ICEM is free to dismiss any application for participation. Final acceptance of a participant occurs through submission of an invoice on which it says: 'For you has been reserved'

### **Dates of the fairs:**

ICEM is entitled either to alter any date set for the fairs or to cancel a fair completely leaving the participant no right to claim any damages.

### **Lay out:**

ICEM can change any allocated place leaving the participant with no relevant claim whatsoever.

### **Rented space:**

ICEM will state the dimensions of the floor space c.q. area rented; floor covering, furnishing, power supply and outlet and construction of the stand is not included in the basic rent.

### **Not dismantling stands:**

The participant is liable for any costs resulting from the untimely dismantlement of a rented stand. In that case ICEM is entitled to take the measures it regards necessary without the participant having any claim.

### **Liability:**

The participant is liable for any damages caused by persons or goods which are present at the fair because or on behalf of him. ICEM is entitled to refuse admission to any staff of the participant without the participant having any claim whatsoever. All goods of the participant present at the fair and at accompanying grounds are completely at the expense and risk of the participant. ICEM is not liable for any damage to goods or persons and caused by whatever reason resulting from participation in the fair. The participant indemnifies ICEM against claims of thirds in relation to use of the stand space.

### **Annulments:**

ICEM can grant a request for annulment of the registration only when this request has been brought to the notice of ICEM at least 60 days before the opening day of the fair in writing and under the condition that the participant is to pay 50% of the rent charged by way of indemnification related to costs made by ICEM. In all other cases the participant is unconditionally bound to fully pay the invoiced costs.

### **Conditions of payment:**

Payment of the invoiced stand rent, possible costs included, must be within 30 days after invoice date unless agreement has been reached in writing otherwise. Received payment will possibly be written off of open accounts first. When payment is late ICEM is entitled to immediately dissolve the contract while the participant is under the obligation to pay the invoiced amount by way of indemnification. When payment in late claim is laid to the lawful interest from 30 days after the date on the invoice while the participant further in indebted to ICEM the costs resulting from any extra-judicial collecting steps hereby fixed at 15% of the claim with a minimum of € 125,-. Any claims or complaints are to be put to ICEM in writing within eight days after the date on the invoice under the penalty of expiration.
